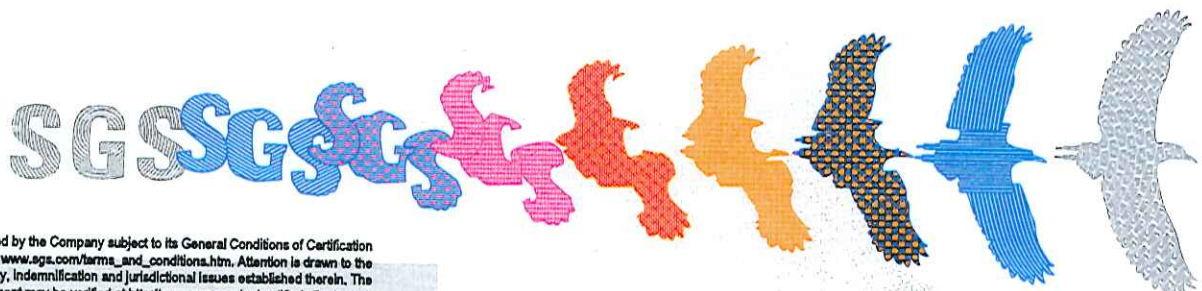

Detailed scope

Einkauf von FSC Recycled aufbereitetem Altpapier und von FSC Mix und FSC Controlled Wood Zellstoff, Herstellung, Weiterverarbeitung und Verkauf von FSC Recycled Tissue Halbfertigware (Mutterrollen) und von FSC Mix und FSC Recycled Tissue Produkten und Toilettenpapier mit dem Prozentsatzsystem. Einkauf und Verkauf von FSC Mix Tissue-Produkte mit dem Transfersystem.

Purchase of FSC Mix, FSC Recycled and FSC Controlled Wood pulp, production, converting and sale of FSC Mix and FSC Recycled semi-finished tissue products (tambours) and of FSC Mix and FSC Recycled tissue products (wet towels, paper towels, toilet paper) using the credit system.

Purchase of FSC Recycled deinked recovered paper and FSC Mix and FSC Controlled Wood pulp, production, converting and sale of FSC Recycled semi-finished tissue products (tambours) and of FSC Mix and FSC Recycled tissue products using the percentage system.

Purchase and sale of FSC Mix tissue products with the transfer system. The covered products and processes are performed by the network of sites, and not necessarily by each of them.
